WHAT TYPES OF FINANCIAL ASSISTANCE ARE AVAILABLE?

ALUMNI SCHOLARSHIP

Florida Tech offers a \$1,000 scholarship to all alumni who wish to pursue a graduate degree online. The scholarship is disbursed in \$250 increments over the first four courses and is available to graduates of ground-based and online programs. Be a Panther for Life!

LAW ENFORCEMENT AND PUBLIC HEROES TUITION SAVINGS

Florida Tech offers a 10% tuition savings for all graduate courses to law enforcement and public safety professionals, including but not limited to police officers, firefighters, paramedic/EMT, Department of Justice federal agents and Department of Homeland Security employees. Each prospective student will be evaluated individually to determine eligibility.

CORPORATE TUITION ASSISTANCE

FEDERAL STUDENT AID

FEDERAL DIRECT LOANS

These student loans must be repaid. If you qualify for a subsidized Federal Direct loan, the government will pay the interest on your loan while you are in school.

ALTERNATIVE LOANS

Filing your Free Application for Federal Student Aid (FAFSA) determines your eligibility for Federal Student Aid.

SUPPORTING OUR NATION'S HEROES

The Department of Defense's MyCAA provides financial assistance to eligible spouses of active-duty and activated Guard and Reserve servicemembers for the purpose of education. Florida Tech welcomes servicemembers from all branches and their family members who have sacrificed for our country to attend our university for special military pricing, regardless of where they are stationed.

We offer a 10% graduate tuition savings for active-duty servicemembers, selected Reservists, National Guard members and honorably discharged veterans, and their spouses.

YELLOW RIBBON PROGRAM

Florida Tech offers matching grants for honorably discharged veterans who are eligible for 100% of the Post-9/11 GI Bill. To take advantage of the Yellow Ribbon Program, you must first apply for benefits.
